CHARTER CONTRACT

This deposit of _____ is to reserve the Nancy Ann IV, _____ on the following dates
_____. Balance due at time of trip.

1. Please make checks out to either Richard Jensen or Nancy Ann Jensen.
2. Deposit shall be forwarded along with a signed copy of this agreement. This agreement will go into effect when deposit is received. Multiple trips need only send one deposit and it will be forwarded down the line to the last trip. Deposit is due within seven (7) days of receiving contract. The party has the right to cancel any trip up to two (2) weeks prior to the scheduled date with refund of deposit. Any trip canceled with less than two weeks notice will forfeit deposit.
3. Sailing Time – Charters will depart rain or shine at a predetermined time. Times may change due to the bite of the fish or tide conditions. Group leaders must call 1-2 days before trip to confirm sailing time.
All passengers should be at boat ready to sail 20 minutes before sailing time. Group leaders should have all cell numbers in case someone is running late.
4. Termination of Trip:
 - A) It is understood that the Captain shall be in charge of the vessel at all times. Conduct on the part of the party which in the Captains discretion may jeopardize the safety of the vessel or the others on board, shall be cause for the Captain to terminate the charter and return to the dock. In the event the charter is terminated in this manner, the full charter price shall nevertheless be due.
 - B) Weather reports are very inaccurate, unless we are in the middle of a storm no trips will be cancelled the day before a trip. All groups are responsible to show up at the dock at the time of the trip. If weather is determined to be unsafe at the time of sailing the Captain will cancel the trip and attempt to reschedule to another day or return deposit.
 - C) The Captain reserves the right to cancel any trip in the event of mechanical failure or illness of the crew. Refund of deposit will be pro-rated based on the hours of the trip actually completed.
5. Alcohol - Beer in limited quantities is permitted. NO LIQUOR OR DRUGS. One of our biggest problems on an evening trip is when people stop to have cocktails before the trip. Please save it for after the trip. You will catch more fish and enjoy yourself more.
6. Tackle - The very best tackle is provided and supplied. Any outfit lost overboard or destroyed will be charged
